From The President Further Reflections on Mentoring

Carlow College, Pittsburgh, Pennsylvania, was chartered as the **Eta Epsilon** Chapter on April 11. Dr. Lucie Young Kelly, National President, conducted the ceremony initiating 150 charter members, including 14 transfer and dual members.

As I meet with Sigma Theta Tau members at charterings, inductions, chapter programs and at all the other professional meetings they attend, I find increasing interest in the mentoring concept. Not just what it is, but the how's of becoming a mentor or protégé. True, a potential protégé can simply be lucky and catch the eye of a nursing leader who sees a responsibility to develop that young person, and the relationship "clicks". That happened to me, and without any equivocation, I can say that my primary mentor, Dr. Ruth Kuehn first dean of the University of Pittsburgh School of Nursing, changed my life.

But, while I consider myself fortunate, for I certainly wasn't looking for a mentor, Dr. Kuehn and others like her did not leave these things to chance. They looked for what they saw as young nurses with the potential to move the profession ahead, and then spent considerable time and energy — always with a palpable spirit of caring — to create what they believed could be a future leader. I wasn't Dr. Kuehn's only protégé; there are others still in key positions today and all of us are an extension of her into the future as we, too, mentor. That is the key — the feeling of commitment to nursing that those in positions of influence have to find, encourage, and nurture promising young nurses (young in the sense of career development if not age). Mentoring someone makes that person a time-consuming part of your life often, though not always, on a very real day-to-day basis. It has to be worth it.

What do a mentors look for? Not just intelligence, although that's almost a given; usually, interest in the same field, if not sub-specialty. But they especially look for a self starter, a hard worker, someone looking for new challenges and directions (yes, risk-takers) someone with good interpersonal and communication skills, someone with a curious mind, who has and understands ideas, someone who wants to

profession; someone with integrity. I would venture to say that for most mentors, another attraction is someone who makes a good appearance, since that person may be seen as representing the mentor. And for many (well, I guess this is personal), a sense of humor is essential.

Does the potential protégé have any preferences? Although there are those who say that they never had, don't need and don't want mentors (and that's all right too), more nurses are beginning to think about what they want in a mentor. Others, who have been mentored, are reflecting about why that relationship worked and why they were willing to be mentored by that person, for clearly, this isn't simply a taking relationship.

The person would, of course, have some prominent, perhaps powerful position in the profession and is generally seen first as a role-model. After years of teaching and talking with nurses, I've concluded that there are certain qualities most attribute to a leader that they respect: intelligent, articulate, courageous (risk-taking), politically astute, honest, fair, visionary, innovative, confident, committed to the profession. Other qualities cited are humor, scholarship, charisma, caring and clinical expertise (for clinicians), but inevitably there was that something else, the chemistry that can't be defined that people look for, or simply feel, in personal relationships.

Don't assume that all mentors or protégés fulfill all of these ideal characteristics, since neither the world nor nursing is made up of paragons; but it's something to think about; my mentor used to say, "Put it on the back burner."
