Background

- Clinical competency in nursing is a significant concept as determined by the IOM Future of Nursing
- No widely accepted understanding of the meaning of clinical competency is found currently in the nursing literature.
- Educating nursing students to achieve an entry level of clinical competency is an essential foundation of the nursing profession.
- Ambiguity in the understanding and measurement of clinical competency may lead to "failure to fail" in the evaluation of the nursing student.

Purpose

- Describe Clinical Competency
- Gain an understanding of the meaning of Clinical Competency from the perspective of pre-licensure baccalaureate nursing faculty and acute care nurse managers

Research Questions

- How do pre-licensure baccalaureate nurse faculty describe clinical competency?
- How do acute care nurse managers describe clinical competency?
- What is the meaning of clinical competency for pre-licensure baccalaureate nurse faculty and acute care nurse managers?
- What are the expectations of clinical competency from the perspective of acute care nurse managers?

Significance of the Study

- Nursing Science and Research
- A consensus of the meaning of clinical competency
- Support of a nursing theory
- An initial step towards the objective evaluation of clinical competency

Nursing Education

- A shared meaning of clinical competency bridging theory to practice
- Support the interests of nursing faculty in preparation of students for the challenges of nursing practice

Nursing Practice

 A clear meaning of clinical competency could assist in the transition of the new graduate in practice and provide support in the their transition

Sample & Setting

- 6-10 Pre-licensure Baccalaureate Nursing Faculty
- 6-10 Acute Care Nurse Managers
- Semi-structured individual interviews
- Convenient Setting for Participants
- Acute Care setting
- University setting

Study Design

- Interpretive Description- a qualitative approach that allows for an understanding of a phenomenon from a clinician's perspective (Thorne, 2008).
- The clinical description of a phenomenon is "interpretive" by nature in nursing.
- There is a recognition of the knowledge and "clinical expertise" of the researcher that contributes to the study.

Data Collection and Analysis

- Recruitment through professional contacts and the snowballing method.
- Digitally recorded semi-structured interviews with acute care nurse managers and prelicensure baccalaureate nursing faculty.
- Inductive analysis using constant comparative analysis technique of each data set.

Interview Questions

- Tell me about your role and contact with student/graduate nurses in the clinical setting.
- Describe the practice of a student/ graduate nurse that you have seen in practice that exemplifies clinical competency.
- Describe the meaning of the concept clinical competency in nursing practice.
- What expectations do you have of the student/ graduate nurses to be considered clinically competent?
